New Business:

Time was spent on the Lawyer's comments and/or corrections and additions to our draft.

Page 7, 4. Utility Grid Wind Energy Systems (WES)

a. 02-11 should be 01-11. (Ask the lawyer on this).

Page 12, 11 Shadow Flicker

d. Typing error "ear" should be "year".

Page 13, a, Table 12-1

Change both Participate and Non-Participate to read 50 feet, not 35 feet. The sound levels stay unchanged in the table.

Changes to the Master Plan

Page 24, Section 6.2 Plan Recommendations

2. Agricultural/Rural Residential. After the first sentence add the following

sentence, "Wind Energy Systems (WES) shall be considered to preserve Agricultural Land for farm use".

Changes to Zoning Ordinance 01-11

Section 305, Table II

Delete "Wind Turbine generators", from Zoning Districts – Agriculture (A), Commercial (C), and Industrial (I). Add to each "WES and Met Towers" in its place.

Residential Single Family (R-A) – Delete "Wind Turbine generators".

Brown has been checking with MTA and Michigan State to receive a check list of law requirements after a hearing.

The Township Board passed a moratorium for Planning to work on Residential Wind and Solar, effective September 10, 2018 to January 2020.

- Wassmann will work on the wording for Table 12-1 using 50 feet and making the text more easily understood.
- Jardis will check on availability of Lawyer to come talk to us on ordinance numbering and can our wind ordinance stand alone referring to the MTA magazine article.
- Peck will check to see if the Township Clerk can help us on hearing detail or if Peck will relieve her as it is also election time for the clerk.

We have set November 7, 2018 at 7:00pm at Mt Haley Township Hall as the hearing date on Wind Energy Systems.
